The Care Economy is a contested issue: a cost problem for neo-liberal strategists, an efficiency obstacle in social and development politics, an antagonism to national migration policies. Women provide three quarters of the care work, at home and on the globalised labour market. The gender asymmetries in the organisation of care and the misevaluation of care work have been at the centre of feminist analysis and struggle. At the conference we will take up these threads and discuss them further in the era of gender mainstreaming and in the context of the multiple global crises - providing a key opportunity to promote alternative concepts of work, livelihoods and well-being and to develop political agency.

## Caring and Social Provisioning as a Starting Point for Feminist Analysis

Who does the care work, under which conditions? How are institutions such as households, markets, public and non-profit sectors involved? From there we set out to exchange experiences and strategies to cope with problems and to challenge gender imbalance. 	Paid care work remains women's business: increasingly informalised and shaped by class and origin. Societies need care, and women need cash. However, their rights are at stake. How do institutions try to improve employment conditions? What can we learn from self-organised women workers to develop joint advocacy?	As farmers, labourers and in households, women are highly involved in the provision of food. The recent food crisis has shown the failure of the existing food system and revealed its blatant gender gap. We link the struggles for the right to food, decent work and gender justice to explore empowering practices and policies.	Heteronormative assumptions of women and men and expectations of their sexual and gender performance inform the predominant body politics. How do they determine women's working conditions, health and social security, way of life and freedoms? And what about men and body politics, masculinities and care?
